The 7/3/2013 WWAC meeting minutes were approved as had been drafted.

Hazardous Thru-Trucking over Snake River Bridge:

- The third week of traffic monitoring was Monday 7/8 to Monday AM 7/15. From 7/8/13 at 9:00am through 7/15 at 7:00am, the mechanical counter recorded:
 - 171 Motorcycles
 2376 Cars
 1440 Pickups/Vans
 11 Buses
 328 trucks with 2 axles & 6 tires
 37 Vehicles with 3 or more axles
- Tim Whiting, Duncan McNeish, Stan Wallerstein, Bruce Bond and Bob Vogler volunteered each spending two hours or more during this third week, recording the types of traffic on Waukewan Road. Their collective report for 10.5 hours is:

9 Motorcycles 271 Cars/SUVs 125 Pickup trucks/Vans (4 wheel) 10 Buses/Trucks with >4 tires 2 Trucks with 3 or more axles

0 Vehicles carrying hazardous materials

 - Pat Tarpey reported that the RFQ has gone out and responses are due by 8/12/13.

- Target expectation is to evaluate 31 properties with 50% of the cost to be paid by the grant and 50% by the property owner.

- John Edgar asked if anyone knew if any group was continuing to do the VLAP water monitoring. Bill Corr reported that the Waukewan and Winona Watershed Protective Association was doing VLAP testing.
- Bob Vogler asked if there is any update on the Foundry Avenue ZBA issue. Answer was no new action has been taken.
- Bob Vogler asked if there have been any cyanobacteria blooms seen this year. Subsequent to the meeting John Edgar reported that he had spoken to Dan Leonard and there have been no blooms seen so far this season.
