  1. Janis has contacted Rudy VanVeghan asking for assistance with the rewriting of the brochure. Mr. VanVeghan suggested we develop an on-line virtual tour.
  2. Suggested Historical Marker made and on put on building mentioned in brochure.
  3. Discussion regarding a tape/phone guided tours be developed
  4. Paul has photos of historical Meredith. Also suggested the use of “then” and “now” pictures.
  5. Those in attendance liked the 8x14 (4 fold) style of brochure
