Having a quorum at 8:02 am, Chairman Randy Eifert opened the meeting.

#### Presentation of VLAP data for local lakes:

- Sara Steiner handed out a 28 page package that contained Chlorophyll-a, Transparency and Total Phosphorus data on Lake Waukewan, Lake Winona, Lake Winnisquam, Lake Pemigewasset & Lake Wicwas. The package also contained Impairment Information for these lakes. Sara presented and led a discussion on all the data.
- Relative to Lake Waukewan, Sara commented on its issues:
  - Chlorophyll-a is approaching the 3.3mg/L max for an oligotrophic lake
  - Phosphorus is approaching the 8.0 mg/L max for an oligotrophic lake
  - Dissolved Oxygen is at a SEVERE impairment level
  - ph is at a POOR impairment level.
- Sara recommends that more water sampling be done for phosphorus from the tributaries flowing into Lake Waukewan.
- Don McFarland pointed out that the Meredith Conservation Commission has acquired testing gear to do take the water samples. Sara reported that the lab cost per sample evaluation for phosphorus by the state labs is \$18 to \$20.

#### The 2/1/2012 WWAC meeting minutes were approved as had been updated.

#### **Email project update:**

- Bob Vogler reported that 225 letters to Lake Waukewan shoreowners on Meredith, Center Harbor & New Hampton were mailed on 2/15/2012
- To date 51 responses have been e-mailed to <a href="www.www.emeredithnh.org">www.emeredithnh.org</a>. The responses have been appreciative and supportive. A few expressed concerns that their e-mail addresses not be misused.
- Bob reported that he has created three distribution lists from these e-mail addresses a Meredith list, a Center Harbor list and a New Hampton list.
