- Action Item: Bob Vogler Update the spreadsheet per today's discussion and send the updated version to all WWAC members via e-mail.
- Action Item: Bruce Bond Request that John Edgar give the WWAC an update on the status of the Septic System Health Ordinance including what open issues are there that need to be resolved before its implementation? What is the target date to implement this ordinance?
- Action Item: Bruce Bond Request Bill Edney get info from Ruel Sweeping on where they dump their road collections?
- Action Item: Bruce Bond Request a copy of the existing Meredith Emergency Response Plan.

## No Pass Through Hazmat Trucks on Winona/Waukewan Roads:

- The past Meredith Town Manager has elected to not take any action on our request that the Meredith Town Manager take the lead to call a meeting of the towns of New Hampton and Center Harbor for the intent to ban pass through Hazmat material trucks from using the Winona & Waukewan Road bypass. It is anticipated that the increased traffic on route 25 caused by the new Hannaford grocery store will make the major roadways on route3/25 through Meredith that much worse next summer.

## Spear (Snake River) property discussion:

- Bill Corr, a Waukewan Shore Owners Association director, reported that the WSOA has agreed
  to take the lead for fund-raising to purchase the 8.5 acre parcel as had been suggested by the
  WWAC at the last meeting. Additionally, the WSOA has agreed to take the lead either act as the
  transfer agent or find someone else to act as the transfer agent. The WWAC members expressed
  full support for this WSOA effort.
- Bruce Bond reported that Lamprey Appraisal has provided an estimate of \$1800 to do an appraisal for the 8.5 acre parcel.

## **Impervious Surface discussion:**

• John Hodsdon reported that he is working on a document that addresses a comprehensive set of issues/Best Management Practices regarding runoff for private land parcels. It's in an early stage of research now, but John agreed to provide in the future a draft of his work for review and comment by the WWAC.

#### **Other Business:**

Bob Vogler reported that he had received an e-mail from Stacy Luke from Ashland saying she
has been asked by the Town of Ashland to be Ashland's representative on the WWAC. Stacy was
unable to attend this meeting, but has indicated she expects to be at our next meeting.
