### **Waukegan Website Status:**

- Bob provided everyone at the meeting with a CD containing the Adobe images of all his material. Bob welcomes recommendations for improvements to the text from WWAC members.

### **Potential New WWAC Members:**

- Peter Miller requested to be put back on the e-mailing list for the WWAC. Additionally, Peter is considering rejoining the WWAC depending on health and timing considerations. He was the Meredith Selectman assigned to the WWAC but was replaced by Bob Flanders at the past election.
- It was suggested that Dave Curran of New Hampton may be a candidate member of the WWAC.

### **Kodiak 5/15/07 Center Harbor Planning Board Summary:**

- No decision was made at the 5/17/07 meeting on the request to expand from 65 people to 90 people and 4 cars to 6 cars.
- The Center Harbor Planning Board wants to determine if it is legally acceptable to grant a one year acceptance of the expansion proposed.
- At the meeting it was suggested that a 300 foot setback from the Snake River be adopted for the camp replacing the current 150 foot setback. The Kodiak reps didn't want to accept this change.
- It is expected that the Center Harbor Planning Board will make a decision on this expansion at their next meeting on 6/5/07 at 6:30 pm at the Center Harbor Town Hall.

### **Status of Bob Hill's proposal for water testing and commercial business BMP analysis:**
