The meeting was called to order at 7:12 pm by Bruce Bond.

The July 27, 2006 Meeting Minutes were accepted as they had been amended per the second updated draft.

The intent of this meeting was to focus on the five Septic System actions in the Management Plan.

1. Develop and implement a septic system inspection program. (1.1.A)

- Bruce opened the discussion asking if there should be different inspection requirements for Unapproved (installed before there were government standards) and Approved Septic Systems.
- The discussion then went to an agreement that we need to get more education on the status of septic systems in the watershed. It was agreed that we should talk to some local septic companies to get their ideas and recommendations.
- **Action Items** Bob Vogler to contact Lamprey Septic and Bruce Bond to contact Maple Ridge Septic.

2. Educate homeowners about septic systems use and maintenance. (1.1.B)

- We have purchased and/or printed 1) Septic System Recordkeeping File and Owner's Guide and 2) You and Your Septic System A Homeowner's Guide to Septic System Maintenance.
- The above materials were available as handouts at the July 15th meeting of the Waukewan Shoreowners, Winona Shoreowners, etc.
- The plan now is to personally hand out the above two materials plus a one page summary of the WWAC accomplishments to date. Members of the WWAC will go door to door around Lake Waukewan and Lake Winona to distribute the materials.
- Action Item Bruce will draft a one page WWAC accomplishments-to-date page.

3. Create a water quality monitoring program to identify failing septic systems along the shorelines. (1.1.C)

- This item was not discussed at this meeting.

4. Tie replacement of septic systems to the building permit process. (1.1.D)

- For starters we want to know how each of the 5 towns handle building permits to modify their properties. Do any of the building permits require a septic system upgrade?
