Meredith Town support to WWAC issues:

- Selectman Rep - We thank Bob Flanders for attending our meeting. With Meredith identifying the protection of its water source as its number one priority, we feel that it is imperative the Selectmen be kept abreast of the actions being pursued by the WWAC.
- Website development – Bruce reported he had met with Eric Ferland regarding the status of the website. The status is:
 - All 106 pages of Bob Wenstrup's work have been entered.
 - About 10% of the text links have been completed.
 - Eric estimates it may take 3 to 6 months to complete the text links.**Action Item: Bob Flanders – Discuss with Carol Granfield to determine how this project may be moved along more quickly.**

- Action Item: Michelle Therrien – Contact Rick Van de Poll to get the original photos from Rick. **Item now closed; Michelle gave two CDs with photos to Bob Vogler on 9/28/07.**
- Action Item – Bob Hill, Get more information on the Commercial site on Foundry Road that is suspected of having a floor drain that has what appears to be bad stuff flowing out of it per Rick Van de Poll. **No update from Bob received; he didn't attend this meeting.**
