Report on the 3 town Conservation Commission meeting re: the Snake River:

- Bruce Bond reported on the meeting of the Conservation Commissions from the towns of Meredith, New Hampton and Center Harbor.
- The Snake River, not being a 4th order river, is not protected by the Shoreland Protection Act.
- The West side of the river is in New Hampton; the East side is in Center Harbor.
- The Center Harbor Conservation Commission intends to request permission from the Center Harbor Board of Selectmen to contact the current owners of the land in Center Harbor to hopefully negotiate an agreement to acquire a conservation easement to preclude future development adjacent to the river.
- At this time, the New Hampton Conservation Commission does not want to try to make any land use regulation changes for the land adjacent to the Snake River.

Open Action Item Status:

• Action Item: Bruce Bond to contact the property owner adjacent to Mayo Farms on the status of the old underground gas tanks. Bruce has not pursued this yet.
